Find the FSO or RFE that needs a duplicate license.

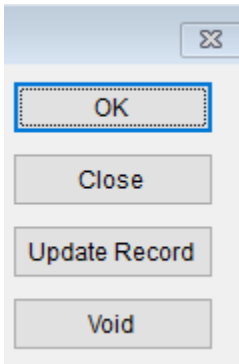
